

Clark County Solid Waste Education and Outreach is recruiting 15 interns to participate in the Compost Academy. Students will receive hands-on experience learning all about composting, sustainable agriculture, and food waste reduction. This internship is in partnership with Vancouver Public Schools.

Students must:

- Be 16-18 years old
- Be enrolled in Hudson's Bay HS or Fort Vancouver HS
- Maintain good attendance and grades
- Complete 60 training hours with the Clark County Compost Academy
- Complete 30 hours of Career Choices curriculum

Minutes Arnada Neighborhood Association Meeting June 12, 2025

April minutes approved.

Treasurer Report- We currently have \$6463.40 in our checking and savings accounts. Total income from Jan-May 2025 is \$324.60 and total expenses are \$551.23. We paid for printing inserts, liability insurance, and snacks for the ivy pull. A grant request for the mural painting was submitted (later learned we were denied, apparently our mural and the way we paint it is not culturally inclusive, who would have thought a flower could be so insensitive?).

Doc wants to get our newsletter into the businesses using a QR linked to the website that we do not have yet. The window stickers and displays are ready. Cano Realty will create the website but we need a place to host it. Roughly \$50-75/year to host. We would need someone interested in maintaining the website long term. If that's you contact any board member.

Police Report-Lee Gelsinger- Continue to call 911 and 311 for everything. Officers are coming against OT, which is typical for summer with more activity. Look into Prop 5 to help fund police services and if we can support that as a neighborhood association. On the Nov. ballot.

Cruise the Couve is coming back. July 19 th . Fourth Plain to Mill Plain. Will have 6-8 police for security.

New officers are training and are on the side streets more to learn more about it. Volunteers also going around with license plate readers. There may be legit plates on a stolen car.

City of Vancouver: Brent Waddle- Check on whether the “No motorized vehicle sign” is at the entrances of the park.

Arnada News:

Thanks to Chelsea, Marin, the City and Ali for organizing the weed pull. We filled up 12 cubic yards of ivy pulled. August 9 th -Mural painting day. Street sweeping on the 8 th . Possibly do our Neighborhood night out party that night while the street is closed. Invite CRESA, police, fire, Green bag people, etc. to come to it.

History walk-July 19 th 11 a.m. Starting at the Arnada Park and ending at the Clark County Historical museum. Would like to request \$150 to cover the cost for those that aren't museum members.

Development Narrative Proposed mixed-use triplex located in the vibrant Uptown Village

Project Overview: The proposed development is a three-story, mixed-use building located on a lot zoned as Community Commercial (CC). The design consists of the following key components:

Ground Floor Commercial Space: Approximately [700 square feet] of flexible commercial space, designed to accommodate a walk-up coffee shop or a therapy office. This will activate the street frontage and provide essential services. Upper Floors Residential Units: Two floors above the commercial space, each housing a well-appointed residential unit (total of two residential units). These units will offer high-quality housing options, contributing to the neighborhood's urban residential character.

Architectural Design: The building will feature a craftsman design that respects the surrounding architectural styles, using high-quality materials and maintaining a pedestrian-friendly streetscape.

Community Benefits: commercial diversity.

Housing Options: The residential units will provide much-needed housing in the downtown area, using the middle housing concept, catering to individuals and families seeking an urban lifestyle.

Sustainable Development: Our design will prioritize energy efficiency, sustainable materials, and minimal environmental impact.

Compliance with Zoning Requirements: The project fully adheres to the zoning regulations of the (CC) district, including permitted uses, height limits, setbacks, and parking requirements. We have designed the building to maintain an active street presence, consistent with the Uptown Village's mixed-use character.

Parking: Two parking spaces supplemented by a sufficient number of bicycle racks to promote sustainable transportation options. This approach aligns with our commitment to a pedestrian-friendly eco-conscious development. This mixed-use triplex will serve as a positive addition to Uptown Village.


